## **Safeguarding Statement for Parents and Carers**

Noah's Ark Preschool is committed to safeguarding and promoting the welfare of children and expects everyone to share this commitment. Safeguarding and promoting the welfare of children is defined as;

- Protecting children from maltreatment.
- Preventing impairment of children's mental and physical health or development.
- Ensuring that children grow up in circumstances consistent with the provision of safe and effective care.
- Taking action to enable all children to have the best outcomes.

## **Our responsibilities**

As a Pre-school, we have a lawful duty to safeguard the welfare of children. We have in place robust safeguarding policies and procedures to support and provide information about the action we will take when there are concerns about a child. Concerns will be brought to the attention of the Designated Safeguarding Lead (DSL), who will decide upon the necessity for a referral to Children's Social Care. In Bristol, First Response is the front door to children's services.

At Noah's Ark Pre-school the DSL is Jane Smith. The Deputy DSLs are Sophie Cleak and Jessica Hollier.

## **Family Support**

We understand that parenting at any stage can be a challenge. Noah's Ark Pre-school will work in partnership with parents and carers who may be affected by difficulties that could be adversely affecting the wellbeing of a child. This can include providing parents with information, advice, and resources as well as signposting to Family Support Services.

Noah's Ark is an Operation Encompass setting. Both the DSL and the Deputy DSL's have received training so are able to provide safe and appropriate support to a child if there is a safeguarding need.

## **Information Sharing**

Noah's Ark Pre-school will be proactive in sharing information as early as possible to help identify, assess, and respond to risks or concerns about the safety and welfare of children, whether this is when problems are first emerging, or when a child is already known to Social Care.

The DSL will discuss child protection concerns with Parents and Carers before referring to other agencies, however, there may be occasions when Noah's Ark Preschool may need to contact another agency (such as First Response) before informing Parents and Carers. The Data Protection Act 2018 and UK General Data Protection Regulations (UK GDPR) do not prevent the sharing of information for the purposes of keeping children safe.

## **Transfer of Safeguarding Records**

To promote a child's welfare and thus their educational needs, records relating to concerns about children will be passed onto the child's next educational setting. Records will be transferred safely and securely.
